

Terms and Conditions

1. Terms

By accessing this web site, you are agreeing to be bound by these web site Terms and Conditions of Use, all applicable laws and regulations, and agree that you are responsible for compliance with any applicable local laws. 4. Membership

LearningPlanet offers utilization of its services under a Membership Agreement. While registering with LearningPlanet you will be prompted for a Payment Card. Upon completing your registration, you may be charged with a Standard Membership Fee of TWENTY-NINE (NZ\$29.00 if within NZ or equivalent if outside NZ) or higher if choosing a larger plan and enter the Membership Agreement. All registration fees in New Zealand will automatically incur GST. The name that will appear on your statement will be LearningPlanet Limited.

The day you complete registration will be known as your monthly Anniversary Date for billing purposes. Please note the Anniversary Date for your records. As soon as the payment is received and cleared you will be emailed all the required log in details and passwords. While bound to the Membership Agreement, you authorize LearningPlanet to charge the amount of your Membership Fee to your Payment Card every THIRTY (30) days beginning on your Anniversary Date. The amount of your Membership Fee upon registration is the same as the Standard Membership Fee, TWENTY-NINE (NZ\$29.00 if within NZ or equivalent if outside NZ). LearningPlanet may offer you additional services for an increased Membership Fee.
